US: Bohra Activist Against FGM Says Veil of Secrecy Keeps Women from Speaking Out



Last week, an Indian American doctor was arrested in Michigan, charged with performing FGM on two seven-year-old girls. *khatna* has been a mandatory religious practice inflicted on Bohra girls all over the world for generations. Bohras are the only Muslims in India who enforce FGM; it's not a common practice among South Asians or Muslims worldwide, and it's not mentioned in the Koran.
